Researcher & Writer, Briefing on Serious Violence Reduction Orders (SVROs)

Feb - Dec 2024 (freelance)

- Researched and co-wrote a report in collaboration with the Centre for Crime and Justice Studies and StopWatch as part of the Young Adult Safety project (funded by the Transition to Adulthood Alliance at the Barrow Cadbury Trust), based on research I led on SVROs, a controversial new type of civil order.
- The briefing covers: the legal framework, political motivation, and policy history of SVROs; implications for human rights, civil liberties, racial disproportionality, police discretion, 18-25 year olds, and procedural justice; the policy's ongoing pilot scheme and its flaws; and the questions that researchers, parliamentarians, lawyers, and campaigners ought to be asking about this policy.

- Generated new research and campaign ideas, including by drafting and submitting FOI requests and analysing police and Home Office and other data.
- Created accessible resources on police powers for community groups, researchers, and educators.

- Regularly responded to requests for comment from journalists on criminal justice topics, including for The Observer, The Independent, openDemocracy, and Byline Times; received media attention across several mainstream news outlets in the UK for my research on stop and search.
